BEQUEST FOR UNRESTRICTED PURPOSES:

I give, devise and bequeath to the UNIVERSITY OF GEORGIA FOUNDATION, a non-profit corporation duly existing under the laws of the State of Georgia and located in Athens, Clarke County, Georgia, the sum of \$ _____ or _____ percent (%) of the rest, residue and remainder of my estate as an unrestricted gift to benefit the Hugh Hodgson School of Music at the University of Georgia.

BEQUEST TO BENEFIT AN EXISTING FUND:

I give, devise and bequeath to the UNIVERSITY OF GEORGIA FOUNDATION, a non-profit corporation duly existing under the laws of the State of Georgia and located in Athens, Clarke County, Georgia, the sum of \$ _____ or _____ percent (%) of the rest, residue and remainder of my estate, for _____^(Fund Name) to benefit the Hugh Hodgson School of Music at the University of Georgia.
