BEQUEST FOR UNRESTRICTED PURPOSES:

I give, devise and bequeath to the UNIVERSITY OF GEORGIA FOUNDATION, a non-profit corporation duly existing under the laws of the State of Georgia and located in Athens, Clarke County, Georgia, the sum of \$ _____ or _____ percent (%) of the rest, residue and remainder of my estate as an unrestricted gift to benefit the College of Public Health at the University of Georgia.

BEQUEST TO BENEFIT AN EXISTING FUND:
